#### MoM

- Agustin went over the Participation Agreement and requested the participants to go through it and propose changes.
- Agustin went over the Guaranteed throughput table, proposed by SCANOSS, which would allow STF to provide a good QoS under the current overall workload of the service and expected growth in 2025.
- General Agreement on keeping this table out of the Participation Agreement since this table is dynamic and might change based on service growth or addition of resources. This table will be part of the OSS KB Program Charter.
- Agreement to bring the approval of the table as a Motion in the next Gov. Board meeting.

- Agustin explains some of the formalisms we will need to go through once the new Charter and Participation Agreement is approved.
  - o Once we approved the new Charter, we introduce the following changes
    - Board Page: Board Members -> Governing Board Member representatives
    - Change the Charter
    - President > Foundation's President, Trustee representative and Governing Board Chair
    - Vice-President -> what would it be his representation?
    - Julián -> Trustee representative
    - Oscar -> SCANOSS representative
  - $\circ$  We would need to go through the corresponding elections for the Governing Board
